Piratesville Splash Pad Private Party Rental Form

Reservations are made on a first-come, first-served basis. Please check availability with Byerly Park staff at (843) 339-2878 or beth.tripp@hartsvillesc.gov before submitting the form to the Coach T.B. Thomas Sports Center at 701 W. Washington St., along with payment.

Rentals include exclusive use of the Splash Pad and picnic shelter, as well as a Splash Pad supervisor. The facility can only be reserved for parties Tuesdays through Sundays during the operating season, before or after normal hours. The Splash Pad is open from 11 a.m. to 7 p.m. Tuesdays through Saturdays, and 1 p.m. to 6 p.m. Sundays. To reserve your party, full payment and completed rental contract must be received.

AGREEMENT

I also agree that the City of Hartsville shall not be liable for the renter, or any of the renter's employees, patron, members, visitors, or guest for an injury or damage to persons or their belongings which result from or during the use of the facility under this Agreement, except as may be caused by an over act or omission by an agent or employee of the City of Hartsville.

PIRATESVILLE RULES AND REGULATIONS

- Piratesville staff comply with SC Department of Health and Environmental Control regulations. Piratesville may be closed because of inclement weather, mechanical failure or any safety issue.
- Children under the age of 16 must be accompanied by an adult.
- Swim suits and/or appropriate attire must be worn at all times. Cut-offs, gym, or dress shorts including thongs and transparent colored suits are prohibited.
- Children not toilet-trained must wear a swim diaper. Regular disposable or cloth diapers will not be allowed. Swim diapers are available for purchase at the concession stand.
- Persons must shower before entering the Splash Pad.
- No person under the influence of drugs or alcohol will be allowed inside the fenced area.
- Persons with diarrhea or nausea will not be permitted on the Splash Pad.
- Persons with skin, eye, or respiratory infections will not be permitted on the Splash Pad.
- Persons with open lesions or wounds will not be permitted on the Splash Pad.
- Glass containers are prohibited within the fenced area.
- During regular operating hours, food and drink are not allowed in Piratesville. For private rentals, outside food and drink are allowed, as concession stand will be closed. There is no refrigeration available.
- Smoking and tobacco products are prohibited except in the parking lot.
- Pets are prohibited within the fenced area.
- Bicycles, scooters, skates, and skateboards are prohibited.
- Running and horseplay are prohibited on the Splash Pad.
- Persons must conduct themselves in a courteous, safe, and family-oriented manner. The use of profanity or abusive language, symbols or gestures may result in removal from the Splash Pad without a refund.
- Athletic equipment, balls, bats, beach balls, noodles, etc. are not allowed on the Splash Pad.
- In the event of threatening weather, the Splash Pad will be closed. We ask that persons go to a safe area. A safe area may be your car or your home. In the event the Splash Pad closes because of severe weather, patrons will be given a pass to re-enter the pad on a future date. This offer is valid for the current season only. No refunds will be given.
- The City of Hartsville reserves the right to remove participants for violating any of the above rules or engaging in illegal, disruptive, destructive, or inappropriate behavior without refund
- The maximum number of users allowed on Splash Pad is 150.
